### MEMBERSHIP AGREEMENT

The Henderson Family YMCA is a nonprofit organization committed to the practice of putting Christian principles into practice through programs that build healthy spirit, mind and body for all. Membership dues are annual and may be paid by monthly bank draft, monthly credit card draft, payroll deduction (where available), or in full for one year. Joining fees and membership dues are not refundable or transferable. Any member who allows their membership to be used by another individual will be subject to having their membership privileges suspended. It is understood that if, for any reason, a bank refuses to honor a draft or credit card, the membership will be void immediately. The membership will be reinstated only after payment of all fees and current dues. A \$35 service charge will be charged for all returned bank or credit card drafts. Members are responsible for notifying the YMCA of any changes in personal or payment information.

**Annual full payment** – memberships paid in full are invoiced for annual renewal approximately 30 days prior to and are payable by the annual renewal date. If membership is allowed to lapse beyond the renewal date, the membership will be void and will not be reactivated until all fees are paid and the account is made current.

**Bank /Credit Card Draft** – the YMCA offers the option of paying annual membership by monthly bank draft or credit card draft which is automatically renewed. In order to cancel, a cancellation form must be signed at the Member Services desk 30 days prior to the draft date.

**Payroll Deduction** – payroll deduction memberships are annual memberships. The YMCA offers the option of paying the annual membership through payroll deduction available through member's employer with the member agreeing to pay the total annual membership and is automatically renewed. In order to cancel, a cancellation form must be signed at the Member Services desk 30 days prior to renewal. Members are responsible for notifying their employer of their wish to cancel.

The YMCA Board of Directors may, at its discretion, adjust the rate of membership. I understand that I will receive notice at least 30 days prior to any adjustment in my membership fee.

By participating in the YMCA Nationwide Membership Program, I agree to release the National Council of Young Men's Christian Associations of the United States of America, and its independent and autonomous member associations in the US and Puerto Rico, from claims of negligence for bodily injury or death in connection with the use of YMCA facilities, and from any liability for other claims, including loss of property, to the fullest extent of the law.

The YMCA conducts regular sex offender screenings on all members, participants, and guests. If a sex offender match occurs, the YMCA reserves the right to cancel membership, end program participation, and remove visitation access.
